LOCATION

The premises are very prominently situated within an established parade of commercial premises located on the junction with Golden Cross Lane and the main Birmingham Road (A38) approx. half a mile from both Junction 1 of the M42 and Junction 4 of the M5. The property is directly opposite **Miller & Carter**, adjacent to **Sculpture Hair Studio** being close **Handle with Care** and **Wilkes Associates Accountants**.

ACCOMMODATION

The premises comprise a self-contained ground floor property with excellent forecourt car parking. The tenants of the flat above the premises are permitted to park one vehicle on the forecourt. Approximate internal dimensions and areas are detailed below:

LEASE
